	Official Documented Meeting Minutes: Anne brought an updated draft of a drawing for the cafeteria that resulted from a meeting on-site on 2/15 and email correspondence with Matt last week. It has been decided to delete the storage room and office from the plan. Anne showed the plan to the group. It was approved. Anne will provide DWG files to ECCI so that the MEP engineers working for the MEP subs can be given them and start their design work. The new cafeteria entry doors will need to open 180 degrees and should be on mag hold open devices. It will be assumed that the VCT adhesive and the chalk board adhesive under the respective existing materials is an ACM. There will be no need for preliminary testing. ECCI will direct the abatement sub to assume they are ACM's and price the work accordingly.
