	Official Documented Meeting Minutes:  Mike stated that the concrete sidewalks at the front of the addition will be placed on Friday. Overlay paving of the existing parking lot from the new sidewalk to the median will happen tentatively next Wednesday. Mike is working with the building inspector to complete final inspections for the addition for next week. The building inspector is stopping by the site today to discuss the final inspection process with Mike. ECCI has been directed to stop the sitework related to the Phase 2 Parking Lot until after the meeting between the SAU and the abutter. This meeting is scheduled for next Monday 7/29. Marc will update ECCI after the meeting and determine how to proceed. The gym painting is done. The wall pads have been installed. The gym floor VCT demo and abatement is wrapping up today and the air test will be performed by the industrial hygienist hired by the SAU this afternoon. Marc has authorized a 24 hour turnaround for test results. The gym floor prep required for the new gym floor will likely start next week. The wall painting in the new cafe is complete. ECCI had to have a new firewall framed on the south end wall of the new cafe as the existing CMU wall stopped just above the ceiling. The VCT work in the cafe is substantially complete. Light fixtures are being installed now. ECCI will work with Oliver Mechanical to determine if roofs are mounted over the new split system condensers as they are under a pitched roof. The kitchen and cafe window demo and replacement will start the week of 8/5/19. Per Marc's request, ECCI asked the design build HVAC sub to determine if the ERV duct trunk in the cafe needed to be insulated. They determined it did and it was insulated.
