To the inhabitants of the School District of Town of Seabrook in the County of Rockingham in the State of New Hampshire qualified to vote in school district affairs are hereby notified and warned that the two sessions of the Annual School District Meeting will be held as follows:

**First Session of Annual Meeting (Deliberative Session):**

Date: Monday, February 5, 2018

Time: 7:00PM

Location: Seabrook Middle School Gymnasium

Details: To explain, discuss, debate and possibly amend the following warrant articles.

**Second Session of Annual Meeting (Official Ballot Voting)**

Date: Tuesday, March 13, 2018

Time: 7:00AM – 7:00PM

Location: Seabrook Recreation Center

Details:

**Article 1: Operating Budget**

Shall the School District raise and appropriate as an operating budget, not including appropriations by special warrant articles and other appropriations voted separately, the amounts set forth on the budget posted with the warrant or as amended by vote of the first session, for the purposes set forth therein, totaling \$13,966,642? Should this article be defeated, the default budget shall be \$13,786,177, which is the same as last year, with certain adjustments required by previous action of the School District or by law; or the governing body may hold one special meeting, in accordance with RSA 40:13, X and XVI, to take up the issue of a revised operating budget only. (Majority vote required.)

Note: Warrant Article #1 (operating budget) does not include appropriations in any other warrant articles. (Should this article be approved, it is estimated it will constitute \$5.379 per thousand of the tax rate.)

**Article 2: Seacoast Educational Support Personnel Association**

To see if the School District will vote to approve the cost items included in the collective bargaining agreement reached between the Seabrook School Board and the Seacoast Educational Support Personnel Association which calls for the following increases in salaries and benefits at the current staffing levels:

Year	Estimated Salary Increase	Estimated Salary Driven Benefits Increase	TOTAL Estimated Cost
2018-19	\$34,032	\$2,733	\$36,765
2019-20	\$26,295	\$2,111	\$28,406

and further to raise and appropriate the sum of \$36,765 for the 2018-19 school year, such sum representing the additional costs attributable to the increase in salaries and benefits required by the new agreement over those that would be paid at current staffing levels in accordance with the current collective bargaining agreement. The School Board and the Budget Committee recommend this appropriation. (Majority vote required.)

Note: In order for this article to be adopted, it must be approved by the voters of the school districts of Hampton Falls, North Hampton, Seabrook, South Hampton and the voters of the Winnacunnet Cooperative School District (which includes Hampton voters).

(Should this article be approved, it is estimated it will constitute \$0.0142per thousand of the tax rate.)

**Article 3: Window Replacement**

To see if the School District will vote to raise and appropriate the sum of \$327,000 to replace the windows in the Seabrook Elementary School? This is the second phase of a two phase project. This will be a non-lapsing appropriation per RSA 32:7, VI and will not lapse until the project is complete or June 30, 2020, whichever is earlier. The School Board and the Budget Committee recommend this appropriation. (Majority vote required.)  
(Should this article be approved, it is estimated it will constitute \$0.1259 per thousand of the tax rate.)

**Article 4: Special Education Expendable Trust**

To see if the School District will vote to raise and appropriate the sum of \$75,000 to be added to the existing Special Education Expendable Trust Fund, with up to \$75,000 to be funded from the June 30, 2018 unassigned fund balance available for transfer on July 1, 2018. No additional amount to be raised from taxation. The School Board and the Budget Committee recommend this appropriation. (Majority vote required.)

**Article 5: Petition Article - Child Benefit Services**

To see if the School District will vote to raise and appropriate the sum of \$27,132 to provide child benefit services, in accordance with RSA 189:49, for students who are residents of the Seabrook School District and attend Sacred Heart School located in Hampton, New Hampshire. CITIZEN'S PETITION by 25 or more registered voters of the Town of Seabrook. The School Board and the Budget Committee recommend this appropriation. (Majority vote required.)  
(Should this article be approved, it is estimated it will constitute \$0.0104 per thousand of the tax rate.)



Polls will not close before 7:00PM.





